Attached is an estimate of water pumped through Sutton for 2011 & 2012 in cubic metres per month. The pump is rated at 350 litres/sec, and is probably 75-80% efficient. An estimate of 1100 cu m/hour is about right.

Both the electricity bills and the telemetry give average monthly hours pumping at about 31 hours.
