Extraordinary General Meeting (EGM)

Following the membership survey, the Committee met to discuss the future direction of BAWAG.It was unanimously agreed that we should become more proactive in our work to safguard licences and in the meeting the challenges from implementation of the Environment Bill.This includes dealing with changes in support payments as well as the transition to new abstraction permitting & charging regimes.Options for change have been considered and will be presented for debate at an EGM to be held:

- Friday 18 February 2022
- Gallows Sports Centre, Fakenham Racecourse

Doors will be open at 10am with tea and coffee available. The meeting will start at 10.30am and will conclude at 12.00 midday, when sandwiches will be served. Ants Broads and Marshes update

Work with the Ant valley Strategy Group & Delivery Group continues, with the Rebuttal Report being reviewed by the Environment Agency and Natural England and progress being made with the draft Ant valley Masterplan.Norfolk County Council are supporting work on the Masterplan, which is based on Treasury guidance for business cases and the Defra/Environment Agency water resource planning guidelines. Following the announcement that Dr Robin Price is returning to Anglian Water, we welcome Daniel Johns as Chair of the Strategy Group.Daniel is the former Head of Public Affairs at Anglian Water and is the new WRE Managing Director.
